### SSF SCHOLARSHIP APPLICATIONS - 2009

SSF has invited applications for scholarship for the year 2009. The application closing date is 31st May 2009. Advertisements were placed in the national newspapers (i.e. Sunday Observer and Thinakaran) in April. The same was announced in the SLBC Muslim news for the message to reach more deserving candidates. So far we have received not more than 750 applications which is a very low turnout compared with past years.

We invite our donors and well wishers to pass on this message to the schools and social service organizations in your hometown to ensure fair distribution of scholarship all over the island.

The shortlisted candidates will be called for a personal interview in the first week of August-2009. The selected candidates will be receiving their scholarship money from January 2010 onward.

Currently SSF is paying Sri Lankan Rupees 1,500/- per student per month. This is paid on a quarterly basis. The recipients need to send quarterly progress reports signed by the head of the institutions for qualifying to receive their payments regularly.

### PARLIAMENTARY INCORPORATION

We are pleased to announce that the draft Act to incorporate Serendib Scholarship Fund at the Sri Lanka Parliament went through its final reading at a Parliamentary standing committee session on 7th May 2009, Alhamduillah. The Parliamentary standing Committee comprising of Hon Chandrasekaran (MP & Chairman of the committees) Hon. Faizer Cassim (MP), Hon. Nowshad (MP), Ven. Vellanvila Thero (MP) passed the Bill and it has to be formally signed off by the parliamentary Speaker in due course. This will, Insha Allah take place in two to three months time. This is a major struggle that SSF has fought for the last 7 years. This incorporation will be a significant milestone in the history of SSF.

Parliamentary incorporation will give 55F more legal status and strengthen its foundation to widen its scope & reach to serve the community better. We wish to place on record our sincere gratitude to all those who helped us in this momentous achievement. May Almighty Allah bless them all.

# ANNUAL GENERAL MEETING

By the grace of Almighty Allah SSF conducted its AGM on 27th February 2009. The members unanimously agreed for the present committee to hold the office with an addition of a new member. The participants expressed their views, suggestions to enhance the services of SSF while clarifying their questions regarding SSF activities over the last one year. The Financials were presented by the treasury team and was adopted by the members.

The president in his speech emphasized the importance of strengthening the Endowment Fund of SSF for ensuring continuity of its services to the community. Endowment Fund will ensure free flow of funds through profits earned from Islamic Investments. The Fund has attracted over US\$ 60,000 at present and its target is to reach US\$ 300,000.

SSF successfully conducted a Majlis in the emirate of Abu Dhabi, United Arab Emirates with the expatriate Muslims on Friday 22nd May 2009. The session started soon after the Jummah prayers followed by a lunch.

A power point presentation was made by the president highlighting the growth of SSF and the importance of its undisputed role to shape up the Muslim community in Sri Lanka. A religious talk followed by networking session was conducted by two committee members. The program was well received by the participation of over 50 people. Approx. 60,000 UAE Dirhams donations was committed by the participants. May Allah reward them abundantly and bestow barakah in their earnings.

### HAI SYDNEY & AUSTRALIANS DONATE AU\$ 20,000

Alhamdulillah, this year too SSF received a generous contribution from the Sydney brothers who have been supporting SSF activities over the last 3 years.
